- f. for the possible establishment, investigation, or defense against claims, which is a legitimate interest of the CCI Katowice (legal basis: Article 6 (1)(f) of the RODO),
- g. for the purpose of evaluating the services provided, conducting satisfaction surveys, which is a legitimate interest of the CCI Katowice (legal basis: Article 6(1)(f) of the RODO),
- h. for the purposes of contact, information, and data exchange, which is a legitimate interest of the CCI Katowice (legal basis: Article 6(1)(f) of the RODO),
- i. for archival (evidential) purposes, to secure information and data if it is necessary to prove the facts, which is a legitimate interest of the CCI Katowice (legal basis: Article 6.1.f of the RODO),
- j. for the purpose of pursuing other legitimate interests of the Administrator or a third party resulting from membership in the CCI Katowice (legal basis: Article 6.1.f of the RODO),
- k. for historical purposes, which is a legitimate interest of the RIG (legal basis: Article 6.1.f RODO). In the case of consent referred to above, I will have the right to withdraw consent at any time without affecting the legality of the processing, which was performed based on consent before its withdrawal.
- 4. My personal data will be processed for the duration of my membership in the CCI Katowice, and after its termination for the period resulting from the applicable laws, and in the case of legitimate interests of the Administrator for the duration of their implementation. In relation to data for which I have given my consent until its withdrawal.
- 5. My personal data can be disclosed to:
 - entities, whose services the Administrator uses in conjunction with its members, i.e.: entities providing consulting, HR and payroll, accounting, tax, legal, accounting, IT, ICT, auditing services, advertising and public relations agencies, subcontractors.

business information agencies, other CCI Katowice Member Companies within the "Members Area".

- 6. Personal data shall not be transferred to a third country or to an international organization. Such a transfer may only take place if it is necessary for the purpose for which the data are processed (for the performance of a contract) and if an adequate level of data protection is ensured. Within the framework of your rights, you have the opportunity to obtain information about the data, where they are made available, and the security measures applied.
- 7. I have the right to demand from the Administrator access to my personal data, their rectification, erasure, or restriction of processing, as well as the right to object and the right to data portability, in accordance with the grounds specified in the RODO (Article 15-22 RODO).
- 8. I have the right to object to the processing of my data for the purposes of direct marketing, as well as, due to my situation (which should be indicated in such a situation), in the case of data processing by the Administrator on the basis of Article 6(1)(f) RODO, i.e., processing of data by the Administrator for the purposes arising from legitimate interests.
- 9. I also have the right to lodge a complaint to the supervisory authority (President of the Office for Personal Data Protection or other competent supervisory authority), if you consider that the processing of personal data violates the provisions of RODO.
- 10. Providing personal data by me is voluntary, however it is necessary to realize the rights and obligations resulting from membership. Providing data is not necessary for the fulfillment of obligations incumbent on the Administrator is subject to statutory requirements arising from mandatory regulations.
- 11. If I do not provide the information CCI Katowice may refuse membership, or I may lose my membership rights.
- 12. I have read and understand the Administrator's Security Policy.

At the same time, I declare that I have been informed that the Administrator reserves the right to use worldwide, free of charge, all photos, film materials, interviews and sound recordings presenting images of participants, trainings, events, and other events organized by the Administrator. They may be used by the Administrator by placing them on CD-Rom, DVD, N in catalogs and in the media, e.g., on websites, in newspapers and exhibitions, as well as for promotional and advertising purposes related to the activity conducted by the Administrator.
